- **Prices:** Prices are determined by TLR and through research to provide best profitable sellable prices. **Consignor** is responsible for confirming selling prices as shown on the Emailed Merchandise List with the understanding that we will have **Sales/Markdowns/Promotions** to help move product.
- **Consignment Split:** Consignor will receive up to 35% - 50% of the actual selling price for each item. The consignment split is solely based brand and age of items. **PLEASE NO EXCEPTIONS**
